### UPDATE ON IPE OFFICE ACTIVITIES

# Faculty Workshop – April 30, 2014

Dr. Narsavage announced that following the Macy Funding Award, a "Save the Date" (attached) flyer has been prepared and distributed via e-mail and e-news by Dr. Rachel Abraham who is leading the workshop planning. Dr. Abraham asked members to distribute the flyer to colleagues from other schools in the Pennsylvania, Ohio, and West Virginia areas. A registration link will be added to the flyer and other workshop announcements for easy registration.

# > Development of Rounding Experience

No updates at this time; the first simulation was January 30, 2014 in Charleston and a second is planned. Some discussion was held regarding cutting back the number of pharmacy students in the next session. Information and photos will be added to the IPE website when available.

#### > Ethics

Dr. Narsavage reported that Dr. Woody Moss, Director for Health Ethics & Law, is continuing to work with Lori Constantine, Palliative Care Nurse Practitioner, School of Medicine and Clinical Instructor in the School of Nursing, to integrate the nursing role into teaching IPE

Ethics in a pilot session, possibly for March 2014. Scott Cottrell noted that an "ethics" session for the SOM has already occurred and that nursing students were not involved. Dr. Narsavage will contact the nursing faculty member for an update and report at the next meeting.

# ➤ InterProfessional Education Collaborative (IPEC) Faculty Development Institute (see attached flyer)

Dr. Narsavage announced that the 2014 IPEC Institute will be held May 4-7 in Herndon, VA. It is entitled: Interprofessional Education: Building a Framework for Collaboration. Attendees will participate in team-based activities and will have opportunities to consult with peers. Each team must have no fewer than three members and no more than five. Dr. Narsavage thinks we should attend and asked for suggestions from members of the Committee as to who would be representative participants as part of the 5 member team. In addition to Dr. Narsavage (SON & IPE lead) suggestions were for Louise Veselicky (SOD), Lauri Andress (SPH), Heather Billings (SOM), Travis White (SOP), with alternates: Ralph Utzman (PT), and Beth Minchau (SON). Dr. Narsavage will contact the participants for interest and send in the application as soon as possible to ensure acceptance – previously the institute filled all places within a week.

#### SPRING SEMESTER IPE SESSIONS

➤ Dr. Narsavage reported that the first pilot seminars were conducted by Dr. Jeannie Sperry on February 10 and 17, 2014. The Topic was Communication. Outcomes were mixed as they experienced multiple technology issues in the IPE Classroom for both video and voice, including microphones not working at tables. Dr. Narsavage has followed up with IT and classroom services and has been assured that an IT technician will be present to assist for at least an hour for future sessions.

The Leadership session scheduled for March 3 was cancelled due to the campus closure due to inclement weather and has been rescheduled to April 21 at 4:30-6:30 with Dr. Cottrell and Dr. DeBiase leading.
