#### APPROVAL OF MINUTES - October 28, 2013

Dr. Narsavage opened the meeting and asked for any changes or additions to the October 28, 2013 Minutes. There being none, the Minutes were approved.

#### DR. ALVIN 'WOODY' MOSS

Dr. Moss provided information on the role playing techniques using hypothetical scripts, which he uses in his Intensive Bioethics courses. He stated that he has seen valuable outcomes from these techniques and recommends the same for IPE sessions with the undergraduate students as well as those in the Graduate and Professional Programs. He highly recommends this method for IPE training for all students (SoM, SoD, SoN, SoP, and SoPH).. Dr. Moss added that the new IPE room would work very well for the student IPE presentations and activities stating that it is an ideal space. Dr. Moss is going to work with SON faculty member Angel Smothers for Spring 2014 sessions to pilot an IPE format.

Dr. Narsavage added that she would like to offer exercises in simulated boards or committees (e.g., Ethics Review board) for the students for further exposure to decision making, communication, and ethical training in the future. This, again, would be in role playing formats and a good practice for the students allowing them to experience the different roles in committee structures.
