II. Discussion

a) Committee Additions, deletions and suggestions

We are currently looking at the composition of the committee and may make some additions to the committee to replace positions that have been vacated due to retirement etc. Lana Bunner, R.N. from Employee Health at U.H.A. has accepted an invitation to be on the committee.

b) Dentistry and Family Practice -Portable Isolation Unit

A portable heap-filtration unit has been purchased by HSC Facilities to be used for isolation purposes when dealing with patients with known or suspected contagious diseases. The unit is being shared and maintained by Family Medicine and Dentistry.

During our discussion regarding the unit, the question arose as to the Cancer Center's protocol in a similar situation. Follow-up with Infection Control will occur. DPS also needs to obtain surgical masks to offer upon patient arrival.

c) Experiment incident in hallway

Recently a Research Associate was carrying plastic vials of sternal cells that were stored in liquid nitrogen from one lab to another. He suspected that the vials became warm, developed vapor pressure and exploded while being transported in the hallway. The cells had no known pathogens. The spill was cleaned with lab-grade disinfectant.

Experiment incident in hallway (continued)

The material should have been transported lab to lab with secondary containment. Additionally, the research associate was not wearing any laboratory personal protective equipment. He should have had a lab coat, gloves and safety glasses on when transporting and working with the material.

d) Webpage
